

COMPETITION LAW AND ANTITRUST STATEMENT

It is a policy of the companies belonging to the SIWAX GROUP ("**Companies**"):

- To compete on the merits of our products and services, on the prices we charge and on the customer loyalty we earn;
- To deal fairly with all customers;
- To ensure that our pricing policies, methodologies and trading terms comply with the relevant competition laws in each jurisdiction in which we conduct business;
- Not to engage in any discussions arrangements or agreements with competitors which result in direct or indirect fixing of a purchase or selling price, fixing of trading terms, or an output restriction, or which give rise to a perception of such an agreement or understanding with competitors;
- Not to engage in any discussions, arrangements or agreements with competitors which results in the allocation of customers, suppliers, territories, or specific goods or services between them, or which gives rise to a perception of such an agreement or understanding with competitors;
- Not to engage in any form of collusive tendering or bid rigging with our competitors;
- Not to exchange competitively sensitive information with our competitors unless the related risk mitigation process has been implemented;
- Not to engage in any prohibited restrictive agreements, arrangements or practices with our customers or suppliers;
- Not to engage in the practice of minimum resale price maintenance;
- Not to engage in any abusive conduct in markets where a company may be held to possess market power;
- To communicate the content of this policy to all relevant employees (including agents) to ensure that they are aware of their responsibilities in relation to compliance with the relevant competition laws;
